### **PATROL DEPUTY** PRIMARY JOB RESPONSIBILITIES

The Patrol Division is the front line of any law enforcement agency. Patrol Deputies are responsible for enforcing laws and answering calls in various districts throughout the county ranging from barking dogs to person and property crimes. As the Patrol Division is often the first point of contact between the HCSO and the community, it is important that Deputies establish a good rapport and communication with the citizens they serve.

Patrol Deputies are responsible for a variety of law enforcement operations from investigating traffic accidents to helping to recover lost or stolen property. Their typical work day will include responding to numerous emergency calls and supporting the needs of our community.

- Polygraph Examination
- Meet the requirements to be P.O.S.T. Compliant
- Background Investigation
- Medical Examination
